COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS – CITY OF BEVERLY HILLS, PRODUCTION WELL PUMPING TEST PROJECT, BEVERLY HILLS, CALIFORNIA (NPDES NO. CAG994005, CI-7400)

We have completed our review of your Notice of Intent (NOI) and analytical results of representative groundwater samples submitted in order to continue enrollment under the General NPDES Permit. Discharge of pumping test water during the startup and shutdown of four potable water wells in the City of Beverly Hills is currently regulated under National Pollutant Discharge Elimination System (NPDES) General Permit No. 994001 (Order No. 97-045), adopted by this Board on May 12, 1977.

Based on the attached Fact Sheet and other information provided, we have determined that the discharge meets the conditions specified in NPDES Permit No. CAG994005, Order No. R4-2003-0108, Waste Discharge Requirements for Discharges of Groundwater from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties (General NPDES Permit No. CAG994005), adopted by this Board on August 7, 2003. Your existing enrollment under NPDES Permit No. CAG994001, Order No. 97-045, which was issued to you on August 21, 2001, is superseded by this new permit that terminated your coverage under Order No. 97-045.

Enclosed are your Waste Discharge Requirements, which also serve as your General NPDES Permit, consisting of Order No. R4-2003-0108 and revised Monitoring and Reporting Program No. CI-7400. The discharge limitations in Part E.1. of Order No. R4-2003-0108 are applicable to your discharge. Discharge from the project drains to Ballona Creek; therefore, the discharge limitations in Attachment B are not applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under Order No. R4-2003-0108. All monitoring reports should be sent to the Regional Board, <u>ATTN: Information Technology Unit.</u> When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-7400 and NPDES No. CAG994005", which will assure that the reports

are directed to the appropriate file and staff. Also, please do not combine your discharge monitoring reports with other reports. Submit each type of report as a separate document.

In order to avoid future annual fees, please submit written notification when the project has been completed and the permit is no longer needed.

We are sending Board Order No. R4-2002-0108 only to the applicant. For those on the mailing list, please refer to the Board Order previously sent to you.
