**CONTINUATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND REVISED WASTE DISCHARGE REQUIREMENTS – HONEYWELL INTERNATIONAL, INC., FOMER HONEYWELL SEPULVEDA FACILITY, 9851 SEPULVEDA BOULEVARD, LOS ANGELES, CALIFORNIA (NPDES NO. CAG914001, CI-8032)**

We have completed our review of your Notice of Intent for the above-referenced facility for a continuation to discharge waste under the National Pollutant Discharge Elimination System (NPDES). Based on the information provided, the discharge from your facility meets the conditions specified in Order No. R4-2002-0107, *Waste Discharge Requirements for Discharges of Treated Groundwater from Investigation and/or Cleanup of Volatile Organic Compounds Contaminated-sites to Surface Waters in the Coastal Watersheds of Los Angeles and Ventura Counties (General NPDES Permit No. CAG914001)*, adopted by this Board on May 23, 2002.

Enclosed are your Waste Discharge Requirements, which also serve as your General NPDES permit, consisting of Order No. R4-2002-0107 and revised Monitoring and Reporting Program (MRP) No. CI-8032. Order No. R4-2002-0127 replaced Order No. 97-044, which has been terminated. The discharge limitations in Part F of Order No. R4-2002-0107 are applicable to your discharge. Discharge from the project drains to Ballona Creek, therefore the discharge limitations in Attachment B are not applicable to your discharge. Compliance with the new permit Order No. R4-2002-0125 and MRP CI-8032 is effective upon receipt of this authorization letter.

All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8032 and NPDES No. CAG914001", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine your discharge monitoring reports with other reports. Submit each type of report as a separate document. In order to avoid future annual fees, please submit written notification when the project has been completed and the permit is no longer needed.
