TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—GOLDEN STATE WATER COMPANY, ENCINITA WATER TREATMENT PLANT, 4836 NORTH ENCINITA AVENUE, TEMPLE CITY, CALIFORNIA (CAG994003, CI—8065)

Dear Ms. Roberts:

In our letter dated September 1, 2004, we informed you that the subject discharge is regulated under Order No. R4-2004-0058, General NPDES and Waste Discharge Requirements for Discharges of Nonprocess Wastewater to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

On April 27, 2009, you informed Regional Board staff that the above-referenced facility last discharge occurred in 2002. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On May 27, 2009, our staff inspected the facility and verified that there is no discharge to the storm drain.

Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2004-0058 for the subject facility is hereby terminated except for enforcement purposes. Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
