

TERMINATING WASTE DISCHARGE REQUIREMENTS
FOR DISCHARGES TO LAND/GROUNDWATER


The California Regional Water Quality Control Board, Los Angeles Region, finds:

1. This Regional Board adopted Waste Discharge Requirements (WDR), Order No. 01-030 for Ventura Farms (Discharger) on February 22, 2001 for discharge of treated groundwater to land at Ventura Farms located at 555 W. Potrero Road, Thousand Oaks, California.
2. On October 30, 2007, this Regional Board enrolled Ventura Farms for groundwater cleanup by in situ chemical oxidation under General Waste Discharge Requirements Order No. R4-2007-0019 (Series No. 038, CI-9336) for Groundwater Remediation at petroleum Hydrocarbon.Fuel and/or Volatile Organic Compound impacted sites.
3. The Board finds that the WDR Order No. 01-030 is no longer applicable and shall be terminated.
4. The termination of WDR is exempt from the provisions of Chapter 3 (commencing with Section 21100), Division 13, Public Resources Code, in accordance with Water Code Section 13389.

This Regional Board has notified the Discharger and interested agencies and persons of its intent to consider termination of Order No. 01-030 and has provided them with an opportunity to submit their written views and recommendations. This Regional Board, in a public hearing, heard and considered all comments and testimony pertinent to the Order.

The Executive Officer of this Regional Board is authorized, and she is hereby directed, to certify and submit copies of this Order to the Discharger, and to such individuals and governmental agencies as may have need therefor, or may request same.
