

TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—CHROMIZING COMPANY, CHROMALLOY LOS ANGELES, 2100 W. 139TH STREET, GARDENA, CALIFORNIA (CAG994004, CI—8254)

Dear Mr. Galati:

In our letter dated September 11, 2007 we informed you that the subject discharge is regulated under Order No. R4-2003-0111, General NPDES and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

We have received and reviewed your October 22, 2008 letter, informing the Regional Board that discharge under this general permit ceased in May 2006 and that the permit is no longer needed at the above-referenced site. Your letter indicated that in November 2007 you applied to the Los Angeles County, Department of Public Works and Sanitation District to discharge your effluent to the sanitary sewer. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On February 4, 2009, our staff inspected the facility and verified that there is no discharge to the storm drain.

Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2003-0111 for the subject facility is hereby terminated except for enforcement purposes. Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
