TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—LOS ANGELES DEPARTMENT OF WATER AND POWER, BURBANK TRUNK LINE PROJECT, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994004, CI-8260)

In our letter dated May 19, 2004, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have reviewed your September 5, 2007, letter requesting termination of coverage under the General NPDES Permit. The letter indicated that you have completed the Burbank Trunk Line Project and wastewater discharge from the subject project to the Los Angeles River has been ceased.

On September 24, 2007, Board staff inspected the facility and verified that there is no discharge of wastewater from the subject site to the Los Angeles River. Since there is no discharge of wastewater from the subject site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004 is hereby terminated, except for enforcement purposes.

Please note that if future discharges of wastewater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain waste discharge requirements.
