TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—UNION OIL COMPANY OF CALIFORNIA FACILITY ID NO. 351708, 6370 STEARNS AVENUE, LONG BEACH, CALIFORNIA (NPDES NOCAG834001, CI-8322)

Dear Mr. Horn:

In our letter dated July 31, 2007, we informed you that the subject discharge is regulated under Order No. R4-2007-0021, Waste Discharge Requirements for Treated Groundwater and Other Wastewaters from Investigation and/or Cleanup of Petroleum Fuel-Contaminated Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

On May 15, 2013, Chevron Environmental Management Company (Chevron) and your consultant ARCADIS informed the Regional Board that discharge of treated groundwater to the storm drain ceased at the site on December 12, 2012. You indicated that future waste discharge from the groundwater treatment system will be discharged to the sanitary sewer system. Since the NPDES permit is no longer necessary, Chevron requested termination of coverage under the above-referenced General NPDES permit.

On July 31, 2013, Regional Board staff inspected the subject project and verified that there is no discharge of groundwater from the site to surface water. Therefore, coverage under Board Order No. R4-2007-0021 for the subject project is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface water or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate Waste Discharge Requirements.
