TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—CENTRAL BASIN MUNICIPAL WATER DISTRICT, RIO HONDO PUMP STATION, 4300 SAN GABRIEL RIVER PARKWAY, PICO RIVERA, CALIFORNIA (NPDES NO. CAG994004, CI-8432)


The subject discharge is regulated under Order No. R4-2003-0111, *General National Pollutant Discharge Elimination System Permit and Waste Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003.

We have reviewed your June 7, 2011, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that you have obtained a construction and project dewatering General NPDES permit Board Order No. R4-2008-0032, Permit No. CAG994004, CI-9658 to cover the discharges from this facility and the previous Order R4-2003-0111 is no longer needed. Therefore, the Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, CI-8432 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
