COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – CITY OF LOS ANGELES- DEPARTMENT OF WATER AND POWER, (HAYNES GENERATING STATION RE-POWERING CONSTRUCTION PROJECT), 6801 WESTMINSTER AVENUE, LONG BEACH (CAG994002, CI-8436)

We have completed our review of your application for a permit to discharge waste under the National Pollutant Discharge Elimination System (NPDES). You have proposed to discharge construction dewatering wastes generated during the installation of subsurface supports for replacement of the electrical generating system at the above-referenced site.

Based on the attached Fact Sheet and other information provided, we have determined that the proposed groundwater discharge meets the conditions to be regulated under Order No. 97-043, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements For Discharges of Treated Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on May 12, 1997.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. 97-043 and Monitoring and Reporting Program No. CI-8436. Prior to starting discharge, a representative sample of the effluent shall be obtained and analyzed to determine compliance with the discharge limitations. The discharge limits in Part E of Order No. 97-043 are applicable to your discharge. The groundwater discharge flows into the San Gabriel River (between Firestone Boulevard and San Gabriel River Estuary), waters of the United States. Therefore, the discharge limits in Attachment A of Order No. 97-043 are not applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8436 and NPDES No. CAG994002", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.
