**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – OXNARD AIRPORT, HANGER III LUFT SITE, 2889 WEST FIFTH STREET, OXNARD, CALIFORNIA (NPDES NO. CAG834001, CI-8511)**

In our letter dated March 12, 2003, we informed you that the subject discharge is regulated under Order No. R4-2002-0125, *Waste Discharge Requirements for Treated Groundwater and Other Wastewaters From Investigation and/or Cleanup of Petroleum Fuel-Contaminated Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on July 11, 2002, which also serves as your NPDES permit.

We have reviewed the August 11, 2004 letter from your consultant, AET Environmental Technologies Inc., which indicated that the groundwater pump-and-treat system at the subject site ceased operation in February 2004. In addition, the letter indicated that you have ceased discharging groundwater from the site to the storm drain system.

On August 17, 2004, Board staff inspected the project site and verified that there is no discharge of treated groundwater from the site to the storm drain. Since there is no discharge of groundwater from the subject site, coverage under Board Order No. R4-2002-0125, General NPDES Permit No. CAG834001, for the subject site is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to Surface Waters or land become necessary, you must file a Report of Discharge with this Board and obtain waste discharge requirements.
