**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – CALCLEAN INCORPORATED, CULVER MOTOR CLINIC, 10707 JEFFERSON BOULEVARD, CULVER CITY (NPDES CAG834001, CI-8541)**

In our letter dated February 21, 2003, we informed you that the subject discharge is regulated under Order No. R4-2002-0125, *General NPDES and Waste Discharge Requirements for Treated Groundwater and Other Wastewaters from Investigation and/or Cleanup of Petroleum Fuel-Contaminated Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

In your letter dated May 12, 2005, you informed Regional Board staff that the groundwater discharge from the above-referenced project has been diverted to the sanitary sewer. Therefore, the NPDES permit is no longer necessary. On May 26, 2005, staff inspected the facility, and verified that there is no discharge to the storm drain.

Since there is no discharge from the project to the storm drain, coverage under Board Order No. R4-2002-0125 for the subject facility is hereby terminated except for enforcement purposes. If you have any questions, please contact Vilma Correa at (213) 576-6794.
