**TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS FOR GROUNDWATER REMEDIATION AT PETROLEUM HYDROCARBON FUEL AND/OR VOLATILE ORGANIC COMPOUND IMPACTED SITES FOR WORLD OIL STATION NO. 65 AT 8020 SANTA MONICA BOULEVARD, WEST HOLLYWOOD, CALIFORNIA (FILE NO. I-04523, ORDER NO. R4-2002-0030, CI 8553, FILE NO. 021)**


Dear Mr. Hundley:

Reference is made to your letter dated January 17, 2006 (copy attached), requesting that we terminate your enrollment under the General Waste Discharge Requirements (Order No. R4-2002-0030), for the regulated re-injection of treated groundwater to the aquifer beneath the site. In your letter, you indicated that the groundwater extraction treatment system has not been in use since April 2004. You also mentioned that a December 28, 2005 letter from the Regional Board (copy attached) stated that the site investigation and corrective action carried out at your underground tank site is in compliance with the requirements of the Health and Safety Code and that no further action related to the petroleum release at the site is necessary,

Since there is no longer a discharge of treated groundwater to the aquifer underneath the site, coverage under Board Order No. R4-2002-0030 for the facility is hereby terminated. However, the recommendations regarding the monitoring wells specified in the December 28, 2005 letter from the Board must be followed.





This letter confirms the completion of a site investigation and corrective action for the underground storage tank(s) formerly located at the above-described location. Thank you for your cooperation throughout this investigation. Your willingness and promptness in responding to our inquiries concerning the former underground storage tank(s) are greatly appreciated.


Based on information in the above-referenced file and with the provision that the information provided to this agency was accurate and representative of site conditions, this agency finds that the site investigation and corrective action carried out at your underground tank(s) site is in compliance with the requirements of subdivision (a) and (b) of section 25296.10 of the Health and Safety Code and with corrective action regulations adopted pursuant to section 25299.3 of the Health and Safety Code and that no further action related to the petroleum release(s) at the site is required.

This notice is issued pursuant to subdivision (g) of section 25296.10 of the Health and Safety Code:

Because the subject site is currently an active gasoline service station, we recommend that you properly maintain all or some existing monitoring wells onsite, so that they would be available should further monitoring be deemed necessary. However, if you choose to abandon these wells, you must comply with the followings:

1. All wells must be located and properly abandoned.
2. Well abandonment permits must be obtained from the Los Angeles County Department of Health Services, Water Well Permits, and all other necessary permits must be obtained from the appropriate agencies prior to the start of work.
3. You must submit a report on the abandonment of the wells to this office by **April 15, 2006**. This report must include, at a minimum, a site map, a description of the well abandonment process, and copies of all signed permits.

The WDR permit was issued to enable regulated re-injection of treated groundwater to the aquifer beneath the site. The groundwater extraction treatment system (GWETS) has been off-line since Quarter 2, 2004 and World has confirmation of the conclusion of corrective action in Los Angeles Regional Water Quality Control Board's (RWQCB) *Underground Storage Tank Program - Case Closure* correspondence dated December 28, 2005 (attached). The final WDR report under this permit was issued by World's consultant, The Source Group, Inc., on January 12, 2006.
