TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS FOR RAYTHEON SYSTEMS COMPANY (FORMER HUGHES MISSILE SYSTEM COMPANY), 8433 FALLBROOK AVENUE, CANOGA PARK, CALIFORNIA (FILE NO. 94-45, ORDER NO. R4-2002-0030, CI-8567) (SLIC NO. 0693, SITE ID NO. 2043T00)

In our letter dated June 19, 2003, we informed you that the subject discharge is regulated under Order No. R4-2002-0030, which also serves as your Waste Discharge Requirements (WDR).

By letter dated November 16, 2005, Ms. Maura Browning of TN & Associates, Inc., on your behalf, notified the Regional Board that work performed for the pilot study has completed in July. Therefore, coverage under Order No. R4-2002-0030 is requested for termination.

Annual Groundwater Monitoring and Groundwater Remediation System Report and Enhanced In-Situ Bioremediation Pilot Study Final Report, January – December 2004 was submitted to the Regional Board detailing the monitoring results and conclusions of the pilot study. Since the pilot study has completed, and the WDR permit is no longer needed, the coverage under Board Order No. R4-2002-0030 for the subject facility is hereby terminated.
