TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—CONOCOPHILLIPS COMPANY, 76 SERVICE STATION NO. 0981, 1004 S. LA CIENEGA BOULEVARD, LOS ANGELES, CALIFORNIA (NPDES NO. CAG834001, CI-8599)

The subject discharge is regulated under Order No. R4-2007-0021, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Treated Groundwater and Other Wastewaters from Investigation and/or Cleanup of Petroleum Fuel-Contaminated Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on April 5, 2007.*

We have reviewed your October 4, 2011, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that you have obtained a permit from City of Los Angeles to discharge treated groundwater to sanitary sewer system and that you have ceased the groundwater discharge to storm drain.

On January 17, 2012, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to the storm drain. Since there is no discharge of groundwater from the facility, coverage under Board Order No. R4-2007-0021, General NPDES Permit No. CAG834001, for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
