

TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS – COUNTRY HILLS DRY CLEANERS, 1155-I DIAMOND BAR BOULEVARD, DIAMOND BAR, CALIFORNIA (SLIC NO. 1001, SITE ID NO. 2040043)

Dear Ms. Drucker:

The California Regional Water Quality Control Board (Regional Board), Los Angeles Region, is the public agency with primary responsibility for the protection of ground and surface water quality for all beneficial uses within major portions of the Los Angeles and Ventura Counties, including the referenced site.

The Regional Board staff has received the request letter dated October 2, 2008 for termination of the subject injection regulated under Order No. R4 - 2002 - 0030, Series No. 029, which also serves you as your Waste Discharge Requirements (WDR) for the Country Hills Dry Cleaners (Site). The Country Hills Dry Cleaners is part of a multi-tenant commercial property located at 1155 South Diamond Bar Boulevard in Diamond Bar, California.

The dry cleaning establishment used tetrachloroethylene (PCE) from 1992 to 2002. Multiple rounds of environmental investigations carried out at the Site detected tetrachloroethylene (PCE) in soil, soil gas and groundwater beneath the Site consistent with chemical usage at the dry cleaning facility. The Regional Board approved a remediation action plan (RAP) for groundwater treatment using Hydrogen Release Compound (HRC) inoculation technology. The implementation of the RAP required WDR. The HRC remedial action was discontinued in June 2003. The Regional Board has ordered further site assessment.

The injection ceased in 2003, therefore the WDR is not needed at this time and the coverage under Regional Board Order No. R4 - 2002 - 0030, Series No. 029 for the subject Site is hereby terminated.
