**TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS – VENTURA COUNTY FIRE STATION # 30, 325 HILLCREST DRIVE, THOUSAND OAKS, CALIFORNIA (FILE NO. 03-108, ORDER NO. R4-2002-0030, SERIES NO. 033, CI-8624)**

Dear Ms. Burns:


In our letter dated July 14, 2006, we informed you that the subject discharge is regulated under Order No. R4-2002-0030, (Series No. 033), which specifies your Waste Discharge Requirements (WDR).

In a letter dated June 30, 2009, you notified the Regional Board that you ceased hydrogen peroxide and Fenton's reagent injection and requested termination of the WDR.

The monitoring results were provided to the Regional Board in quarterly monitoring reports. Since you have completed the hydrogen peroxide and Fenton's reagent injection and no longer need the WDR, the coverage under Board Order No. R4-2002-0030, (Series No. 033), for the subject facility is hereby terminated with the exception of enforcement under the term of the permit.


