RESCISSION OF "STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 2012-0032, APPROVING WATER QUALITY CONTROL POLICY FOR SITING, DESIGN, OPERATION, AND MAINTENANCE OF ONSITE WASTEWATER TREATMENT SYSTEMS" DATED JULY 30, 2018, ISSUED TO MIRAMAR INVESTMENTS COMPANY OFFICE BUILDINGS AT 23805-23815 STUART RANCH ROAD, MALIBU, CA 90265 (Order No. 01-031, SERIES NO. 047, FILE NO. 03-110, CI NO. 8631, GLOBAL ID WDR100000504)

Dear Ms. Gartland:

The California Regional Water Quality Control Board, Los Angeles Region (Regional Board), is the public agency with primary responsibility for the protection of ground and surface water quality for all beneficial uses of water within major portions of Los Angeles and Ventura Counties, including the Miramar Investments Company Office (Facility) mentioned above.

On July 30, 2018, the Regional Board inadvertently issued a letter to waive the waste discharge requirements for the Facility located at 23805-23815 Stuart Ranch Road, Malibu, California. Because the Facility is subject to the Onsite Wastewater Disposal Systems Prohibition as set forth in the Water Quality Control Plan for the Los Angeles Region, the Facility does not qualify for the Tier 0 waiver. Therefore, the July 30, 2018 Tier 0 waiver letter is hereby rescinded. Your Facility's discharge of wastewater continues to be regulated under waste discharge requirements contained in Order No. 01-031 until the connection to the Malibu Civic Center Wastewater Treatment Facility is completed, and the coverage is terminated.
