**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—EXXONMOBIL CORPORATION—FORMER EXXON STATION 7-2827, 305 CARMEN DRIVE, CAMARILLO, CALIFORNIA (NPDES NO. CAG834001, CI-8663)**

Dear Mr. Hanley:

In our letter dated July 27, 2007, we informed you that the subject discharge is regulated under Order No. R4-2007-0021, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Treated Groundwater and Other Wastewaters from Investigation and/or Cleanup of Petroleum Fuel-Contaminated Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on April 5, 2007.

On July 10, 2013, you informed Regional Board staff that the above-referenced project was completed and the subject NPDES permit is no longer needed. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On March 17, 2015, staff inspected the facility and verified that there is no discharge of groundwater to the storm drain. Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2007-0021, General NPDES Permit No. CAG834001, CI-8663 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
