MONITORING MODIFICATION RELATED TO CHANGE THE INJECTION VOLUMES AND CONCENTRATIONS OF SODIUM LACTATE FOR GROUNDWATER REMEDIATION PILOT STUDIES – ANADITE SOUTH GATE, 10647 GARFIELD AVENUE, SOUTH GATE, CALIFORNIA (CAO NO. 98-004, FILE NO. 97-019, SLIC NO. 541, SITE ID NO. 2041C00)

Dear Mr. Curtas:

Los Angeles Regional Water Quality Control Board (Regional Board) staff have reviewed your September 28, 2005 request to modify groundwater remediation pilot study operations at the referenced site. The groundwater remediation pilot studies at the site have been conducted since June 2004 under Waste Discharge Requirements (WDR) Order No. R4-2002-0030 (revised as R4-2005-0030 in April 2005) and Monitoring and Reporting Program No. CI-8685. The modification is made to increase the injection volumes and concentrations of sodium lactate at pilot study No. 2 and No. 3 areas. Pilot study No. 1 was largely unsuccessful and has been terminated.

Enclosed are your Waste Discharge Requirements, consisting of Regional Board Order No. R4-2005-0030 (Series No. 043) and Revised Monitoring and Reporting Program No. CI-8685. Please note that the water quality objectives in Attachment A (DWR Basin No.4-11 [Central Basin]) of Order No. R4-2005-0030 are applicable to your discharge.

The "Monitoring and Reporting Program" requires you to implement the monitoring program on the effective date of this enrollment (December 30, 2005) under Regional Board Order No. R4-2005-0030. All Monitoring Reports (two copies per report) shall be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8685", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Please submit each type of reports as a separate document.
