Dear Dr. Kurtz:

Reference is made to the Notice of Termination dated February 4, 2004, requesting that we terminate your enrollment under the Statewide General Waste Discharge Requirements (Order No. 2003-0003), for discharges to land with a low threat to water quality. Regional Board staff inspection of the site on February 5, 2004 found the sump had been removed and the surrounding area cleared. The Discharge Monitoring Program was implemented on January 2, 2004, and the required monitoring report was received on February 6, 2004.

Since there is no longer a discharge of well development water from the site, and all reporting requirements have been met, coverage under State Board Order No. 2003-0003-DWQ for the facility is hereby terminated.
