ORDER No. R4-2009-0085

TERMINATING WASTE DISCHARGE REQUIREMENTS FOR DISCHARGES TO LAND/GROUNDWATER

The California Regional Water Quality Control Board, Los Angeles Region, finds:

- 1. This Regional Board adopted Waste Discharge Requirements (WDR), Order No. R4-2004-0125 for Larry Canchola and Mojdeh Daneshrad (Discharger) on August 5, 2004 for discharge of ozone into the shallow aquifer to remediate contaminated groundwater at the former Venice McLaughlin Center located at 11614 Venice Blvd., Los Angeles, California.
- 2. On May 20, 2009, the Discharger notified this Regional Board that it did not plan to inject ozone into groundwater at the site.
- 3. The Regional Board finds that WDR Order No. R4-2004-0125 is no longer applicable and shall be terminated.
- 4. The termination of WDR is exempt from the provisions of Chapter 3 (commencing with Section 21100), Division 13, Public Resources Code, in accordance with Water Code Section 13389.

This Regional Board has notified the Discharger and interested agencies and persons of its intent to consider termination of Order No. R4-2004-0125 and has provided them with an opportunity to submit their written views and recommendations. This Regional Board, in a public hearing, heard and considered all comments and testimony pertinent to the Order.

The Executive Officer of this Regional Board is authorized, and she is hereby directed, to certify and submit copies of this Order to the Discharger, and to such individuals and governmental agencies as may have need therefor, or may request same.
