TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—SNYDER-MASSELIN VENTURE, L.P., OFFICE DEPOT, 5665 WILSHIRE BOULEVARD, LOS ANGELES (CAG994004, CI-8791)

In our letter dated July 27, 2004, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, General NPDES and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

On November 27, 2007, you informed Regional Board staff that the above-referenced project was completed in January 2006. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On November 28, 2007, our staff inspected the facility and verified that there is no discharge to the storm drain.
