**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – CALCLEAN, INC., 10148 ROSECRANS AVENUE, BELLFLOWER, CALIFORNIA (NPDES NO. CAG994004, CI-8851)**

The subject discharge is regulated under Order No. R4-2003-01111, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have reviewed your June 28, 2006, letter which requested termination of coverage under the General Permit. You have indicated that this permit is no longer needed for the project.

On June 30, 2006, Board staff inspected the project site and verified that there is no discharge of groundwater from the site to San Gabriel River. Since there is no discharge of groundwater from the subject site, coverage under Board Order No. R4-2003-01111, General NPDES Permit No. CAG994004, for the subject site is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain waste discharge requirements.
