**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—HARSU GAS MART, 17903 E. VALLEY BOULEVARD, LA PUENTE, CALIFORNIA (NPDES NO. CAG994004, CI-8888), CALIFORNIA**

Dear Mr. Judge:

The subject discharge is regulated under Order No. R4-2008-0032, *Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008.

We have reviewed your June 26, 2009, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that you have completed the groundwater cleanup project and that the discharge from the subject facility to the San Gabriel River has been ceased.

On January 7, 2011, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to the San Gabriel River. Since there is no discharge of groundwater from the facility, coverage under Board Order No. R4-2008-0032, General NPDES Permit No. CAG994004, for the facility is hereby terminated.


