

TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – CITY OF PORT HUENEME TRITON PUMP STATION ELIMINATION PROJECT, PIPELINE ALIGNMENT NO.1, CHANNEL ISLAND BLVD. & PATTERSON ROAD, PORT HUENEME, CALIFORNIA (NPDES NO. CAG994004, CI-9027)

In our letter dated January 30, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have reviewed your March 19, 2007, letter requesting termination of coverage under the General NPDES Permit. The letter indicated that you have completed the Triton Pump Station Elimination Project and groundwater discharge from the subject facility to the Channel Islands Harbor has been ceased.

On June 14, 2007, Board staff inspected the facility and verified that there is no discharge of groundwater from the subject site to the Channel Islands Harbor. Since there is no discharge of groundwater from the subject site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004 is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain waste discharge requirements.
