**COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – THE NEWHALL LAND AND FARMING COMPANY, SEGMENT G OF RIVER PARK DEVELOPMENT, NEWHALL RANCH ROAD/BOUQUET CANYON ROAD, VALENCIA, CALIFORNIA (NPDES NO. CAG994004, CI-9115)**

We have completed our review of your application for a permit to discharge groundwater to surface waters under a National Pollutant Discharge Elimination System (NPDES) permit. You propose to discharge up to 2.5 million gallons per day (mgd) of groundwater during construction dewatering and bank stabilization of the Santa Clara River at the above-referenced land development project located in Valencia. The short-term construction dewatering will be completed within six months. The high rate of discharge is necessary because the construction project is being conducted within the bank of the Santa Clara River. Should the construction project for this segment last past six months, then the discharge rate will be limited to no greater than 1.0 mgd.

Based on the attached Fact Sheet and other information provided, we have determined that the proposed discharge at the above-referenced site meets the conditions to be regulated under Order No. R4-2003-0111, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. R4-2003-0111 and Monitoring and Reporting Program No. CI-9115. The discharge limitations in Part E.1.a and b.i of Order No. R4-2003-0111 for the specific constituents listed on the Table with the enclosed Fact Sheet are applicable to your discharge. The groundwater discharge flows into the Santa Clara River (between Lang Gaging Station and Bouquet Canyon Road Bridge). The dewatering is taking place immediately adjacent to the Santa Clara River. Your discharge has been determined to satisfy the provisions for creekside dewatering, therefore the discharge limitations in Attachment B.3.b. of Order No. R4-2003-0111 are not applicable to your discharge, except those for boron and nitrogen.
