TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT — G.B. COOKE, INC. – CITY OF MALIBU CIVIC CENTER STORMWATER TREATMENT FACILITY PROJECT, CROSS CREEK ROAD & CIVIC CENTER WAY, MALIBU, CALIFORNIA (NPDES NO. CAG994004, CI-9129)

In our letter dated July 12, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have reviewed the February 20, 2007, letter from your consultant, Pure Effect Inc., requesting termination of your coverage under the General Permit. The letter indicated that you have ceased discharging groundwater from the subject project site since November 2006.

On February 21, 2007, Board staff inspected the project site and verified that there is no discharge of groundwater from the site to the Malibu Creek. Since there is no discharge of groundwater from the site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, for the subject site is hereby terminated except for enforcement purposes.
