TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—CITY OF LOS ANGELES, DEPARTMENT OF WATER AND POWER, HANSEN AREA WATER RECYCLING PROJECT, 1801 SHELDON STREET, SUN VALLEY (CAG674001, CI-9133)

In our letter dated July 27, 2006, we informed you that the subject discharge is regulated under Order No. R4-2004-0109, General NPDES and Waste Discharge Requirements for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

In your letter dated May 12, 2008, you informed Regional Board staff that the above-referenced project was completed on February 21, 2008. Since the NPDES permit is no longer necessary. you requested termination of your coverage under the above-referenced General NPDES permit. On June 17, 2008, Regional Board staff inspected the facility and verified that there is no discharge to surface waters from the project.

Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2003-0109 for the subject facility is hereby terminated except for enforcement purposes. Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
