TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—LNR – LENNAR WASHINGTON SQUARE LLC., WASHINGTON SQUARE PROJECT, 300-330 WASHINGTON BOULEVARD, MARINA DEL REY, CALIFORNIA (NPDES NO. CAG994004, CI-9138)

In our letter dated October 30, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

On February 18, 2009, you informed Regional Board staff that the above-referenced project was completed. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On May 29, 2009, our staff inspected the facility and verified that there is no discharge to the storm drain.

Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2003-0111 for the subject facility is hereby terminated except for enforcement purposes. Please note that if future discharges of groundwater to surface waters become necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
