TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—110/105 FREEWAY INTERCHANGE STORM WATER MANAGEMENT PROJECT, CALIFORNIA (NPDES NO. CAG994004, CI-9177)

In our letter dated September 27, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have received and reviewed your November 4, 2008 letter, requesting termination of your coverage under the General Permit. The letter indicated that you have completed the construction project and have ceased discharging groundwater from the subject facility to the Los Angeles River.

On November 19, 2008, Board staff inspected the project site and verified that you have completed the project contract term with the California Department of Transportation and you are not the present contractor operating the facility at this time. Therefore, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, for the subject project is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters become necessary, you must file a Report of Waste Discharge with this Board and obtain waste discharge requirements.
