Our letter dated March 27, 2009, transmitted the tentative Revised Waste Discharge Requirements (WDR) for above-referenced site. Pursuant to Division 7 of the California Water Code, this Regional Board at a public hearing during the Board meeting held on June 4, 2009, reviewed the tentative Revised WDRs, considered all factors in the case, and adopted the Revised WDR Order No. R4-2009-0072 relative to the East Complex.
