TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—CALIFORNIA DEPARTMENT OF WATER RESOURCES, PEACE VALLEY PIPELINE REPAIR PROJECT (STATE WATER PROJECT), 2 MILES NORTH OF PYRAMID LAKE—NEAR 138 AND 5 INTERSTATE FREEWAY, PEARBLOSSOM, CALIFORNIA (NPDES NO. CAG994004, CI—9307)

In our letter dated August 9, 2007, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have received and reviewed your July 11, 2008 letter, requesting termination of your coverage under the General Permit. The letter indicated that you have completed the Peace Valley Pipeline Repair Project and that the groundwater discharge from the subject facility to the Santa Clara River has been ceased. Since there is no discharge from the subject site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, for the subject project is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters become necessary, you must file a Report of Waste Discharge with this Board and obtain waste discharge requirements. If you have any questions, please contact Namiraj Jain at (213) 620-6003.
