TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—ERMINE STREET, LLC C/O BROOKFIELD RESIDENTIAL—KEYSTONE FUTURE HOUSING PROJECT, GOLDEN VALLEY ROAD AT NEWHALL RANCH ROAD, SANTA CLARITA, CALIFORNIA (NPDES NO. CAG994004, CI—9372)

Dear Mr. Ritz:

In our letter dated November 12, 2014, we informed you that the subject discharge is regulated under Order No. R4-2013-0095, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 6, 2013.


We have reviewed your December 7, 2018, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that the construction dewatering project was completed and that the subject NPDES permit is no longer needed.

On June 20, 2019, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility into the Santa Clara River. Since there is no discharge of wastewater from the project site, coverage under Board Order No. R4-2013-0095, General NPDES Permit No. CAG994004, CI-9372 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of wastewater to surface water or land becomes necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters or land.
