TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—PARVIZ KHASHOY, MARSEL PLAZA LLC, 1080 S. LA CIENEGA BLVD., LOS ANGELES, CALIFORNIA (NPDES NO. CAG994004, CI-9385)

Dear Mr. Khakshooy:

The subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008.

We have reviewed a letter from your company dated July 6, 2012, requesting termination of your coverage under the General Permit. The letter indicated that discharge at the above-referenced project has been routed to the local sewer system and that the subject NPDES permit is no longer needed.

On July 13, 2012, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to surface water. Since there is no discharge of groundwater from the facility, coverage under Board Order R4-2008-0032, General NPDES Permit No. CAG994004, for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
