TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—CITY OF SANTA CLARITA, DEPARTMENT OF PUBLIC WORKS—GOLDEN VALLEY ROAD BRIDGE PROJECT, GOLDEN VALLEY AND SANTA CLARITA RIVER, CALIFORNIA (NPDES NO. CAG994004, CI—9464)

Dear Mr. Nay:


In our letter dated September 18, 2008, we informed you that the subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.*

On May 3, 2010, you informed Regional Board staff that the above-referenced project was completed in March 2010 and the subject NPDES permit is no longer needed.

On January 24, 2011, Board staff inspected the facility and verified that there is no discharge of groundwater to the storm drain. Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2008-0032 for the subject facility is hereby terminated. Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging.




