TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—SOUTHERN CALIFORNIA GAS COMPANY, LINE 324 OXNARD RELOCATION PROJECT, BETWEEN RICE AVENUE AND GONZALES ROAD, OXNARD, CALIFORNIA (CAG994004, CI—9502)

Dear Mr. Warr:

In our letter dated April 20, 2009, we informed you that the subject discharge is regulated under Order No. R4-2008-0032, General NPDES and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

On June 11, 2009, you informed Regional Board staff that the above-referenced project was completed on June 10, 2009 and discharge under this general permit did not occur. Therefore the subject NPDES permit is no longer needed.

On June 24 2009, Board staff inspected the project site and verified that there is no discharge of groundwater to the storm drain. Since there is no discharge from the site to the storm drain, coverage under Board Order No. R4-2008-0032 for the subject project is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements prior to discharging any groundwater from the site to surface waters.
