COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) AND WASTE DISCHARGE REQUIREMENTS—KAF INVESTMENTS, LLC –8833 CYNTHIA STREET CONDO BUILDING, 8833 CYNTHIA STREET, WEST HOLLYWOOD, CALIFORNIA (NPDES NO. CAG994004, CI-9517)

Dear Mr. Feig:

We have completed our review of your application for a permit to discharge waste under the National Pollutant Discharge Elimination System (NPDES). You propose to discharge up to 1,000 gallons per day of groundwater from the aforementioned facility.

Based on the information provided, the proposed discharge of groundwater meets the conditions to be regulated under General Permit No. CAG994004, Order No. R4-2008-0032; *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008.

Enclosed are your Waste Discharge Requirements, which also serve as your General NPDES Permit, consisting of Order No. R4-2008-0032 and Monitoring and Reporting Program No. CI-9517. The discharge limitations in Part V.1. Table 1 of Order No. R4-2008-0032 for the specific constituents listed on the Table with the enclosed Fact Sheet are applicable to your discharge. The groundwater discharge flows to the Ballona Creek. Therefore, the discharge limitations in Attachment B are not applicable to your discharge. Prior to starting discharge, a representative sample of the effluent must be obtained and analyzed to determine compliance with the discharge limitations.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-9517 and NPDES No. CAG994004", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.

In order to avoid future annual fees, please submit written request for termination of your enrollment under the general permit in a separate letter, when your project has been completed
