**REVISED MONITORING AND REPORTING PROGRAM NO. CI-9634 – CANNERS STEAM COMPANY, 249 CANNERY STREET, SAN PEDRO, CALIFORNIA (FILE NO. 10-146, ORDER NO. R4-2007-0019, SERIES NO. 160, CI-9634, GLOBAL ID. WDR100000193)**

Dear Ms. Bay:

On October 20, 2010, the California Regional Water Quality Control Board, Los Angeles Region (Regional Board) enrolled you under general Waste Discharge Requirements (WDR Order No. R4-2007-0019) with a Monitoring and Reporting Program (MRP) No. CI-9634 for the application of RegenOx and Oxygen Release Compound (ORC) to remediate volatile organic compounds (VOCs) and total petroleum hydrocarbons (TPHs) in soil and groundwater at the subject site.

On behalf of Canners Steam Company, TRC Companies, Inc. submitted the *Proposed Additional Groundwater Remediation Activities (Work Plan)*, dated April 17, 2014 for additional injection of ORC to further treat residual VOCs and TPHs in groundwater. It is estimated that 1,100 gallons of 15% ORC solution will be injected into 5 injection wells at depths approximately from 10 to 12 feet below ground surface. On April 29, 2014, Regional Board Site Cleanup staff approved the Work Plan. The proposed injection shall not exceed 1,100 gallons of 15% ORC solution at 5 injection wells as indicated in the Figure 1 of the revised MRP. The injection activities are expected to take approximately two weeks.

In addition, Canners Steam Company requested to reduce the groundwater monitoring frequency to a semi-annual basis for monitoring wells MW-7, MW-9, MW-11, and MW-12 because these wells do not contain detectable concentrations of VOCs and TPHs.

Based on the review of information submitted and groundwater monitoring data from December 2012 to March 2014, Regional Board staff determined that the wells IW-1 through IW-5, MW-4R, MW-5, MW-6, MW-8, and MW-10 are sufficient to monitoring additional ORC injection activity. Also, concentrations of VOCs and TPHs in wells MW-7, MW-9, MW-11, and MW-12 have been below laboratory reporting limits since December 2012. Therefore, the groundwater monitoring frequency for wells MW-7, MW-9, MW-11, and MW-12 can be reduced to semi-annual basis.

The revised MRP, which incorporates injection of ORC solution and modification to the groundwater monitoring frequency, is enclosed. The proposed discharge shall not cause the mineral constituents of the receiving groundwater at the compliance point, downgradient outside the application area, in excess of applicable limits (West Coast Basin of the Los Angeles Coastal Plain Groundwater Basin) given in Attachment Table 3-10 of Order No. R4-2007-0019. The next monitoring report is due on **July 15, 2014** as required in the revised MRP. Please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.

The Discharger shall comply with the Electronic Submittal of Information (ESI) requirements by submitting all reports required under the MRP, including groundwater monitoring data, discharge location data, and pdf monitoring reports to the State Water Resources Control Board GeoTracker database under Global ID WDR100000193. For all parties who upload electronic documents to State Database GeoTracker, it is no longer necessary to email a copy of these documents to [losangeles@waterboards.ca.gov](mailto:losangeles@waterboards.ca.gov) or submit hard copies to our office. The Regional Board will no longer accept documents (submitted by either hard copy or email) already uploaded to GeoTracker. To avoid paying future annual fees, please submit a written request for termination of your enrollment under the general WDR in a separate letter when the project is completed and the WDR is no longer needed. Be aware that the annual fee covers the fiscal year billing period beginning July 1 and ending June 30, the following year. You will pay the full annual fee if your request for termination is made after the beginning of the new fiscal year beginning July 1.

I. MONITORING AND REPORTING REQUIREMENTS

- A. Canners Steam Company (hereinafter Discharger) shall implement this Monitoring and Reporting Program (MRP) on the effective date (June 27, 2014) under Regional Board Order No. R4-2007-0019. The next monitoring report under this program shall be received at the Regional Board by **July 15, 2014**. Subsequent monitoring reports shall be received at the Regional Board according to the following schedule:

<u>Monitoring Period</u>	<u>Report Due</u>
January – March	April 15
April – June	July 15
July – September	October 15
October – December	January 15

- B. If there is no discharge or injection, during any reporting period, the report shall so state. By March 1 of each year, the Discharger shall submit an annual summary report to the Regional Board. The report shall contain both tabular and graphical summaries of the monitoring data obtained during the previous calendar year. In addition, the Discharger shall discuss the compliance record and the corrective actions taken or planned, which may be needed to bring the discharge into full compliance with the waste discharge requirements.
- C. The Discharger shall comply with requirements contained in Section G of Order No. R4-2007-0019 "*Monitoring and Reporting Requirements*" in addition to the aforementioned requirements.

**II. DISCHARGE MONITORING PROGRAM**

The monitoring reports shall contain the following information regarding the injection activities:

1. Location map showing injection points used for the Oxygen Release Compound (ORC) solution.
2. Written and tabular summary defining depth of injection points, quantity of the ORC solution injected at each injection point, and total amount of the ORC solution injected at the Site.
3. Visual inspection at each injection point shall be conducted and recorded during the injection.

**III. GROUNDWATER MONITORING PROGRAM**

A groundwater monitoring program shall be implemented to evaluate impacts associated with the injection activity. Groundwater samples shall be collected from monitoring wells IW-1 through IW-5, MW-4R, MW-5, MW-6, MW-7, MW-8, MW-9, MW-10, MW-11, and MW-12 (Figure 1). The Discharger shall conduct a baseline sampling prior to the proposed injection, followed by specified schedules from all 14 monitoring wells for the following groundwater parameters:

**Quarterly for wells IW-1 through IW-5, MW-4R, MW-5, MW-6, MW-8, and MW-10  
and semi-annually for wells MW-7, MW-9, MW-11, and MW-12**

All groundwater monitoring reports must include, at minimum, the following:

- a. Well identification, date and time of sampling;
- b. Sampler identification, and laboratory identification;
- c. Quarterly observation of groundwater levels, recorded to 0.01 feet mean sea level and groundwater flow direction.

**IV. MONITORING FREQUENCIES**

Specifications in this monitoring program are subject to periodic revisions. Monitoring requirements may be modified or revised by the Executive Officer based on review of monitoring data submitted pursuant to this Order. Monitoring frequencies may be adjusted to a less frequent basis or parameters and locations dropped by the Executive Officer if the Discharger makes a request and the request is backed by statistical trends of monitoring data submitted.

**V. CERTIFICATION STATEMENT**

Each report shall contain the following completed declaration:

"I certify under penalty of law that this document, including all attachments and supplemental information, was prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gathered and evaluated the information submitted. Based on my inquiry of the person or persons who manage the system, or those persons directly responsible for gathering the information, the information submitted is, to the best of my knowledge and belief, true, accurate, and complete. I am aware that there are significant penalties for submitting false information, including the possibility of a fine and imprisonment.



