TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS ORDER NO. R4-2014-0187, SERIES NO. 027 – FORMER ITT CORPORATION, HUMBOLDT STREET PROPERTY, 300 WEST AVENUE 33 (FORMERLY 3209 HUMBOLDT STREET), LOS ANGELES, CALIFORNIA 90031 (FILE NO. 09-172, WDR ORDER NO. R4-2014-0187, SERIES NO. 027, CL-9652, GLOBAL ID WDR100001502)

Dear Mr. Stanek:

On January 6, 2015, ITT Corporation (ITT) submitted a Report of Waste Discharge to inject cheese whey, emulsified vegetable oil, and Dehalococcoides into groundwater for the in-situ bioremediation of chlorinated volatile organic compounds. On July 3, 2015, the Los Angeles Regional Water Quality Control Board (Regional Water Board) authorized the injection under General Waste Discharge Requirements Order No. R4-2014-0187, General Waste Discharge Requirements for In-Situ Groundwater Remediation and Groundwater Reinjection (General WDR), at the site referenced above. The authorized discharge was implemented under the November 22, 2013, Remedial Action/Design Implementation Work Plan for In-Situ Reactive Zone (IRZ) Groundwater Treatment, approved by the Department of Toxic Substances Control on August 13, 2014.

On June 27, 2019, ITT requested termination of coverage under the General WDR because the injection of cheese whey, emulsified vegetable oil, and Dehalococcoides ended in August 2017. Additional injection is not planned at this time. Therefore, the General WDR is no longer needed. Coverage under General WDR Order No. R4-2014-0187 is hereby terminated except for enforcement purposes.
