TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—PHILLIPS 66 PIPELINE, LLC—EAST TERMINAL HYDROSTATIC TEST PROJECT, 13500 SOUTH BROADWAY STREET, LOS ANGELES, CALIFORNIA (NPDES NO. CAG674001, CI—9719)

Dear Mr. Phelan:


In our letter dated June 20, 2011, we informed you that the subject discharge is regulated under Order No. R4-2009-0068, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds in Los Angeles and Ventura Counties*, adopted by this Board on June 4, 2009.

We have reviewed your September 26, 2012, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that hydrostatic test project was completed and the permit is no longer needed. On June 17, 2013, Board staff inspected the project site and verified that there is no discharge of hydrostatic test water from the facility to the storm drain. Since there is no discharge of hydrostatic test water from the project site under Board Order No. R4-2009-0068, General NPDES Permit No. CAG674001, CI-9719 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain waste discharge requirements.
