TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—CAMROSA WATER DISTRICT, WOODCREEK WELL, 5300 LYNWOOD DR, CAMARILLO, CALIFORNIA (NPDES NO. CAG994005, CI 9932)

Dear Mr. Stafford:

In our letter dated April 23, 2013, we informed you that the subject discharge is regulated under Order No. R4-2003-0108, General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

On September 4, 2013, Layne, on behalf of Camrosa Water District, informed the Regional Board that Layne has concluded all discharges related to the subject project. Since the NPDES permit is no longer necessary, Layne requested termination of coverage under the above-referenced General NPDES permit.

On February 3, 2014, Regional Board staff inspected the subject project and verified that there is no discharge of groundwater from the site to surface water. Therefore, coverage under Board Order No. R4-2003-0108 for the subject project is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface water or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate Waste Discharge Requirements.
