TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT— CALLEGUAS MUNICIPAL WATER DISTRICT— SALINITY MANAGEMENT PROJECT CONTROL TANK, PROJECT NO. 513, SOUTH LEWIS ROAD AND CAWELTI ROAD, CAMARILLO, CALIFORNIA (NPDES NO. CAG674001, CI— 9995)

Dear Ms. Mulligan:

In our letter dated October 23, 2013, we informed you that the subject discharge is regulated under Order No. R4-2009-0068, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds in Los Angeles and Ventura Counties*, adopted by this Board on June 4, 2009.

We have reviewed your September 21, 2015, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that hydrostatic test project was completed and the permit is no longer needed. On June 6, 2016, Board staff inspected the project site and verified that there is no discharge of hydrostatic water from the project site to the storm drain. Since there is no discharge of hydrostatic water from the project site, coverage under Board Order No. R4-2009-0068, General NPDES Permit No. CAG674001, CI-9995 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of hydrostatic test water to surface water or land becomes necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters or land.
