## TENTATIVE WASTE DISCHARGE REQUIREMENTS-GENERAL NPDES PERMIT FOR DISCHARGES OF TREATED GROUNDWATER AND OTHER WASTEWATERS FROM INVESTIGATION AND/OR CLEANUP OF PETROLEUM FUEL-CONTAMINATED SITES TO SURFACE WATERS IN COASTAL WATERSHEDS OF LOS ANGELES AND VENTURA COUNTIES (GENERAL NPDES PERMIT NO. CAG834001)

Enclosed are copies of the tentative Waste Discharge Requirements and General National Pollutant Discharge Elimination System Permit for Discharges of Treated Groundwater and Other Wastewaters from Investigation and/or Cleanup of Petroleum Fuel-Contaminated Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties.

The draft permit is scheduled for consideration at the June 14, 2018, Board meeting. Upon adoption, the discharges currently enrolled under the Order No. R4-2013-0042 will be re-enrolled into the adopted general permit, upon submission of completed Notice of Intent Form.
