LOCATION CHANGE FOR BOARD HEARING AND TRANSMITTAL OF RESPONSE TO COMMENTS FOR THE TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRS) AND GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR DISCHARGE OF LOW THREAT HYDROSTATIC TEST WATER TO SURFACE WATERS IN COASTAL WATERSHEDS OF LOS ANGELES AND VENTURA COUNTIES (NPDES NO. CAG674001)

On March 19, 2019, the Los Angeles Regional Water Quality Control Board (Regional Water Board) transmitted the tentative Waste Discharge Requirements (WDRs) and General National Pollutant Discharge Elimination System (NPDES) permit for Discharge of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties. We have received comments by May 19, 2019, public comment deadline from Los Angeles Department of Water & Power and Shell Oil Products US. The Regional Water Board considered the comments and is providing our responses to the comments as shown in the enclosed Response to Comments. In addition, we have revised the tentative permit previously transmitted to you. Changes in the revised tentative are highlighted as shown in the enclosed documents.

In the March 19, 2019, letter, we also informed you that the May Board hearing would be held at the City of Malibu, at 23825 Stuart Ranch Road, Malibu, California, at 9:00 a.m. on May 9, 2019. However, the location of the public hearing at which your item will be heard has been changed to the City of Agoura Hills, at 30001 Ladyface Court, Agoura Hills, California. The date and time of the public hearing remain the same.

In accordance with administrative procedure, the Regional Water Board at a public hearing to be held on May 9, 2019, at 9:00 a.m., at the City of Agoura Hills, at 30001 Ladyface Court, Agoura Hills, will consider the revised tentative WDRs and General NPDES permit that was transmitted to you on March 19, 2019. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further investigation.
