TENTATIVE WASTE DISCHARGE REQUIREMENTS-GENERAL NPDES PERMIT FOR DISCHARGES OF NONPROCESS WASTEWATER TO SURFACE WATERS IN COASTAL WATERSHEDS OF LOS ANGELES AND VENTURA COUNTIES (GENERAL NPDES PERMIT NO. CAG994003)

Enclosed are copies of the tentative Waste Discharge Requirements and General National Pollutant Discharge Elimination System Permit for Discharges of Nonprocess Wastewater to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties.

The draft permit is scheduled for consideration at the April 9, 2020, Board meeting. Upon adoption, the discharges currently enrolled under the Order No. R4-2014-0060 will be reenrolled under the adopted general permit, upon submission of a completed Notice of Intent Form.
