### **REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND WATER RECLAMATION REQUIREMENTS (WRRs) FOR WATER REPLENISHMENT DISTRICT OF SOUTHERN CALIFORNIA, GROUNDWATER RELIABILITY IMPROVEMENT PROJECT- ADVANCED WATER TREATMENT FACILITY, (FILE NO. 17-008, CI 10318)**

We have revised the tentative WDRs/WRRs dated July 20, 2018, based on comments received by the August 20, 2018, public comment deadline. A copy of the revised tentative Order and written responses to all comments received are enclosed. Changes to the tentative WDRs/WRRs appear in strikeout and underline format. Written comments are not being solicited regarding the revised tentative Order.
