TENTATIVE WASTE DISCHARGE REQUIREMENTS - SAN CLEMENTE ISLAND LANDFILL, LOS ANGELES COUNTY, CALIFORNIA (FILE NO. 84-035)

Dear Mr. Gordon:

Reference is made to our letter to you on August 19, 2009, informing you that your Report of Wasted Discharge for the subject site was complete. In accordance with the California Water Code, Regional Board staff have prepared tentative waste discharge requirements for the landfill. Enclosed are copies of the Tentative Requirements¹, consisting of:

- a. Board Order
- b. Monitoring and Reporting Program (Attachment T)
- c. Definitions (Attachment A)
- d. Standard Provisions Applicable to Waste Discharge Requirements (Attachment W)

In accordance with administrative procedures, this Regional Board, at a public hearing to be held on March 4, 2010, at 9:00 AM, Metropolitan Water District of Southern California, 700 North Alameda Street, Board Room, in Los Angeles, California, will consider the enclosed tentative Order and comments submitted in writing regarding any or all portions thereof. The Regional Board will hear any testimony pertinent to this discharge and the tentative requirements. It is expected that the Regional Board will take action at the hearing; however, as testimony indicates, the Regional Board at its discretion may order further investigation.

Written comments regarding the tentative Order must be received at the Regional Board office by the close of business on February 15, 2010, in order to be evaluated by Board staff and included in the Board's agenda folder. Submittal of written comments by the deadline is required to ensure that all comments are accurately and fully included in the administrative record, that Board staff is able to provide timely review, and that Regional Board members have sufficient time to give full consideration to the comments and issues raised.
