TENTATIVE ORDER TO TERMINATE INDIVIDUAL WATER RECLAMATION REQUIREMENTS FOR TOP O'TOPANGA COMMUNITY ASSOCIATION WASTEWATER TREATMENT PLANT LOCATED AT 3360 NORTH TOPANGA CANYON BOULEVARD, TOPANGA, CALIFORNIA 90290 (FILE NO. 61-149, ORDER NO. R4-2025-XXXX, CI-3185, GLOBAL ID WDR100000744)

Dear Ken Solomon:

On May 12, 1997, the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) adopted Order No. 97-071, which prescribes Water Reclamation Requirements (WRRs) and Monitoring and Reporting Program (MRP) No. CI-3185 for the discharge of recycled wastewater from the Top O'Topanga Community Association Wastewater Treatment Plant, located at 3360 North Topanga Canyon Boulevard, Topanga, California 90290 (Facility).

On April 29, 2025, the Top O'Topanga Community Association (Discharger) was authorized to discharge recycled wastewater from the Facility under the General WDRs set forth in Los Angeles Water Board Order No. R4-2019-0024 (Series No. 066) and MRP No. CI-3185.

Enclosed is the tentative Order proposing the termination of WRRs previously established under Order No. 97-071. This tentative Order is also available on the [Los Angeles Water Board's website](#).

The Los Angeles Water Board hereby invites public comments on the proposed termination of the WRRs. In accordance with administrative procedures, the Board is scheduled to consider the tentative termination Order, along with all timely received public comments, during a public hearing to be held at **9:00 a.m. on June 26, 2025, at 320 West 4th Street, Los Angeles, California 90013 (Carmel Room)**. A virtual participation option will also be available for those who would like to join the meeting online. Please refer to the meeting agenda for instructions on how to register for or view the meeting online.

During the hearing, the Los Angeles Water Board will accept testimony relevant to the discharge and the tentative termination Order. While the Board is expected to take action

at the hearing, it reserves the right to request additional investigation if warranted by the testimony presented.

To ensure review by Los Angeles Water Board staff and inclusion in the Board members' agenda packets, written comments or evidence regarding this tentative termination Order must be received by the Los Angeles Water Board no later than 5:00 p.m. on **May 30, 2025**. Failure to meet this deadline may result in the exclusion of the submitted materials from the administrative record.

Timely submittal is essential to ensure that all comments are accurately incorporated into the administrative record, that staff has adequate time to review and prepare responses, and that Board members have sufficient opportunity to consider the issues raised prior to the hearing.
