# I. Order

This Clean Water Act (CWA) section 401 Water Quality Certification action and Order (Order) is issued at the request of City of Culver City (herein after Permittee) for the Project. This Order is for the purpose described in application and supplemental information submitted by the Permittee. The application was received on September 22, 2014. The application was deemed complete on March 14, 2018.

# II. Public Notice

The Los Angeles Water Board provided public notice of the application pursuant to California Code of Regulations, title 23, section 3858 from September 14, 2014 to the effective date of Order. The Los Angeles Water Board did not receive any comments during the comment period.

# III. Project Purpose

The purpose of the Project is to replace existing Higuera Street Bridge over Ballona Creek.

# **IV.** Project Description

The Project will replace the existing bridge including widening the bridge from approximately 41 feet to 70 feet. The existing structure will be replaced by a single-span cast-in-place bridge with pre-stressed concrete box girders and 24-inch cast-in-drilled-hole piles positioned between the existing steel piles. The new bridge will have two 12-foot vehicle lanes, a 5-foot bike lane, and a 6-foot sidewalk in each direction. With implementation of the Project, one vehicle lane will be added to the bridge to close the existing gap, thus eliminating the bottleneck. The number of through lanes at the adjacent Higuera Street intersections (two lanes in each direction) would remain the same; therefore, the Project will not increase capacity. The Project will also include a new ramp connection from Higuera Street to the bike path.

To complete the Project, right of way (ROW) acquisition of approximately 791 square feet (0.02 acre) of private land adjacent to the bridge will be required from two parcels to the south of the bridge (Assessor's Parcel Number [APN] 4205-025-008 and APN 4205-025-003). Permanent easements of approximately 5,171 square feet (0.12 acre) of land will be required from three Los Angeles Flood Control District (LACFCD) parcels adjacent to the bridge.

The project will include the construction of a crosswalk at the Higuera Street/Eastham Drive intersection. The crosswalk will connect to a bike and pedestrian ramp at the southwest corner of the bridge that will connect to the existing bike path that crosses under the bridge. The final location of temporary construction easements (TCE) will be determined during final design. During construction, the bridge will be closed to traffic; however, optional routes to cross Ballona Creek will be available, including National Boulevard and Duquesne Avenue. A traffic management plan (TMP) identifying detour routes will be developed during final design.

Several utilities within the existing bridge structure will be replaced, including an American Telephone and Telegraph (AT&T) telephone conduit and a Golden State Water Company water main (to be upgraded). Existing Southern California Edison (SCE) high voltage transmission power poles on the north side of the bridge will be protected in place, with the exception of one guy-wire pole at the southwest corner of the bridge. There are streetlight, traffic signal, sewer, and storm drain facilities both east and west of the bridge structure. Streetlight and traffic signal pull boxes, cabinets, and other facilities will be relocated, and

storm drain catch basins, adjacent driveway approaches, and signs will be reconstructed and adjusted to grade. One drainage outlet located at the southwest corner of the bridge, which currently drains onto the bike path, may need to be relocated.

During the time of construction, it is expected that no federally listed (threatened or endangered) species and designated critical habitat or state listed species will be within the biological study area (BSA), which comprises of approximately 1.82 acres of land that consist of the proposed bridge, roadway, bike path footprint, vegetated areas at the top to the concrete-lined creek banks, and the creek channel from 100 feet upstream to 100 feet downstream of the bridge. However, there is potential for migratory birds to be within the BSA and the bridge demolition as well as the vegetation removal could result in the direct impact of the nesting birds and roosting bats.

A water diversion may be required for the project and will consist of two sandbag berms installed in a V-shape that would direct the flows into a plastic culvert pipe, or similar. The water diversion would extend for approximately 241 feet to enclose water in the project area and prevent work in flowing water. Flows would be unimpeded and would be released approximately 100 feet downstream of the project area. If required, the water diversion plan will be submitted to the appropriate resource agencies for review and approval prior to the start of dewatering operations.

# V. Project Location

The Project is located on Higuera Street in Culver City, Los Angeles County.

## VI. Project Impact and Receiving Waters Information

The Project is located within the jurisdiction of Los Angeles Regional Water Quality Control Board. Receiving waters and groundwater potentially impacted by this Project are protected in accordance with the applicable water quality control plan (Basin Plan) for the region and other plans and policies which may be accessed online at:

<u>http://www.waterboards.ca.gov/plans\_policies/</u>. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the state, water quality objectives to protect those uses, and the state and federal antidegradation policies.

It is the policy of the State of California that every human being has the right to safe, clean, affordable, and accessible water adequate for human consumption, cooking, and sanitary purposes. This Order promotes that policy by requiring discharges to meet contaminant levels designed to protect human health and ensure that water is safe for domestic use.

## VIII. Compensatory Mitigation

No compensatory mitigation is required for impacts because the impacts are temporary in nature and concrete to concrete.

## IX. California Environmental Quality Act (CEQA)

On November 14, 2016, the City of Culver City, as lead agency, adopted an initial study/negative declaration (IS/ND). The Los Angeles Water Board is a responsible agency under CEQA (Pub. Resources Code, § 21069) and in making its determinations and findings, must presume that City of Culver City's adopted environmental document comports with the requirements of CEQA and is valid. (Pub. Resources Code, § 21167.3.) The Los Angeles Water Board has reviewed and considered the environmental document and finds that the environmental document prepared by City of Culver City adequately addresses the Project's water resource impacts. (Cal. Code Regs., tit. 14, § 15096, subd. (f).)

## X. Petitions for Reconsideration

Any person aggrieved by this action may petition the State Water Board to reconsider this Order in accordance with California Code of Regulations, title 23, section 3867. A petition for reconsideration must be submitted in writing and received within 30 calendar days of the issuance of this Order.

#### XI. Fees Received

An application fee of \$4,096 was received on 9/22/2014. Certification is conditioned upon total payment of \$5,971. The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as Fill and Excavation Discharges with the dredge and fill fee calculator.

# XII. Conditions

The Los Angeles Water Board has independently reviewed the record of the Project to analyze impacts to water quality and designated beneficial uses within the watershed of the Project. In accordance with this Order, the Permittee may proceed with the Project under the following terms and conditions:

# A. Authorization

Impacts to waters of the state shall not exceed quantities shown in Table 1.

## B. Reporting and Notification Requirements

Requirements for the content of these reporting and notification types are detailed in Attachment C, including specifications for photo and map documentation during the Project. Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment C, which must be signed by the Permittee or an authorized representative.

# 1. Project Reporting

a. Annual Reporting: The Permittee shall submit an Annual Report each year on the anniversary of the Project effective date. Annual Reporting requirements are detailed in Attachment C. Annual reporting shall continue until a Notice of Project Complete Letter is issued to the Permittee.

# 2. Project Status Notifications

- a. Request for Notice of Completion of Discharges Letter: The Permittee shall submit a Request for Notice of Completion of Discharges Letter following completion of active Project construction activities, including any required restoration and permittee-responsible mitigation. This request shall be submitted to the Los Angeles Water Board staff within thirty (30) days following completion of all Project construction activities. Upon acceptance of the request, Los Angeles Water Board staff shall issue a Notice of Completion of Discharges Letter to the Permittee which will end the active discharge period and associated annual fees.
- b. Request for Notice of Project Complete Letter: The Permittee shall submit a Request for Notice of Project Complete Letter when construction and/or any postconstruction monitoring is complete,<sup>3</sup> and no further Project activities will occur. This request shall be submitted to Los Angeles Water Board staff within thirty (30) days following completion of all Project activities. Upon approval of the request, the Los Angeles Water Board staff shall issue a Notice of Project Complete Letter to the Permittee which will end the post discharge monitoring period and associated annual fees.
- **3. Conditional Notifications and Reports:** The following notifications and reports are required as appropriate.

# a. Accidental Discharges of Hazardous Materials<sup>4</sup>

Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Wat. Code, § 13271):

- As soon as (A) Permittee has knowledge of the discharge or noncompliance, (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures then:
  - first call 911 (to notify local response agency)
  - then call Office of Emergency Services (OES) State Warning Center at: (800) 852-7550 or (916) 845-8911
  - Lastly follow the required OES procedures as set forth in: <u>http://www.caloes.ca.gov/FireRescueSite/Documents/CalOES-Spill\_Booklet\_Feb2014\_FINAL\_BW\_Acc.pdf</u>
- **ii.** Following notification to OES, the Permittee shall notify Los Angeles Water Board, as soon as practicable (ideally within 24 hours). Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- **iii.** Within five (5) working days of notification to the Los Angeles Water Board, the Permittee must submit an Accidental Discharge of Hazardous Material Report.
- b. Violation of Compliance with Water Quality Standards: The Permittee shall notify the Los Angeles Water Board of any event causing a violation of compliance with water quality standards. Notification may be via telephone, e-mail, or delivered written notice.
  - i. Examples of noncompliance events include: lack of storm water treatment following a rain event, discharges causing a visible plume in a water of the state, and water contact with uncured concrete.
  - **ii.** This notification must be followed within three (3) working days by submission of a Violation of Compliance with Water Quality Standards Report.

## c. In-Water Work

i. If stream diversion will be necessary, the Permittee shall submit to the Los Angeles Water Board staff a Stream Diversion Plan, with a diagram and a narrative description of the method to divert the stream and associated BMPs for acceptance at least 30 days in advance of any stream diversion.

<sup>&</sup>lt;sup>4</sup> "Hazardous material" means any material that, because of its quantity, concentration, or physical or chemical characteristics, poses a significant present or potential hazard to human health and safety or to the environment if released into the workplace or the environment. "Hazardous materials" include, but are not limited to, hazardous substances, hazardous waste, and any material that a handler or the administering agency has a reasonable basis for believing that it would be injurious to the health and safety of persons or harmful to the environment if released into the workplace or the environment. (Health & Saf. Code, § 25501.)

- ii. During stream diversion, water quality monitoring shall be conducted. Requirements for water quality monitoring are below.
- iii. The Permittee shall notify the Los Angeles Water Board at least forty-eight (48) hours prior to initiating work in water or stream diversions. Notification may be via telephone, e-mail, or delivered written notice.
- iv. Within three (3) working days following completion of work in water or stream diversions, an In-Water Work/Diversions Water Quality Monitoring Report must be submitted to Los Angeles Water Board staff.

#### d. Modifications to Project

Project modifications may require an amendment of this Order. The Permittee shall give advance notice to Los Angeles Water Board staff if Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority by submitting a Modifications to Project Report. The Permittee shall inform Los Angeles Water Board staff of any Project modifications that will interfere with the Permittee's compliance with this Order.

- e. Transfer of Property Ownership: This Order is not transferable in its entirety or in part to any person or organization except after notice to the Los Angeles Water Board in accordance with the following terms:
  - i. The Permittee must notify the Los Angeles Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Permittee and purchaser must sign and date the notification and provide such notification to the Los Angeles Water Board at least 10 days prior to the transfer of ownership.
  - **ii.** Until such time as this Order has been modified to name the purchaser as the permittee, the Permittee shall continue to be responsible for all requirements set forth in this Order.

# C. Water Quality Monitoring

- 1. General: If surface water is present, continuous visual surface water monitoring shall be conducted to detect accidental discharge of construction related pollutants (e.g. oil and grease, turbidity plume, or uncured concrete).
- 2. Accidental Discharges/Noncompliance: Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard, Los Angeles Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.

## 3. In-Water Work or Diversions:

During planned work in water or stream diversions any discharge(s) to waters of the state shall conform to the following water quality standards:

- a. Oil and Grease. Waters shall not contain oils, greases, waxes or other materials in concentrations that result in a visible film or coating on the surface of the water or on objects in the water, that cause nuisance, or that otherwise adversely affect beneficial uses.
- **b.** Dissolved Oxygen. The dissolved oxygen content of all surface waters designated as WARM shall not be depressed below 5 mg/L as a result of waste discharges.
- *d.* pH. The pH of inland surface waters shall not be depressed below 6.5 or raised above 8.5 as a result of waste discharges. Ambient pH levels shall not be changed more than 0.5 units from natural conditions as a result of waste discharge.
- e. Turbidity. Downstream TSS shall be maintained at ambient levels. Where natural turbidity is between 0 and 50 Nephelometric Turbidity Units (NTU), increases shall not exceed 20%. Where natural turbidity is greater than 50 NTU, increases shall not exceed 10%.

Sampling shall be conducted in accordance with Table 2 sampling parameters.<sup>5</sup>

Baseline sampling shall be conducted at least one location within the project boundary for each phase. All other sampling shall take place at a minimum of two locations. In streams or flowing water the sample locations shall be upstream and downstream. Results of the analyses shall be submitted to this Regional Board by the 15th day of each subsequent sampling month. A map or drawing indicating the locations of sampling points shall be included with each submittal.

# D. Standard

<sup>&</sup>lt;sup>5</sup> Pollutants shall be analyzed using the analytical methods described in 40 Code of Federal Regulations Part 136; where no methods are specified for a given pollutant, the method shall be approved by Los Angeles Water Board staff. Grab samples shall be taken between the surface and mid-depth and not be collected at the same time each day to get a complete representation of variations in the receiving water. A hand-held field meter may be used, provided the meter utilizes a U.S. EPA-approved algorithm/method and is calibrated and maintained in accordance with the manufacturer's instructions. A calibration and maintenance log for each meter used for monitoring shall be maintained onsite.

- 1. This Order is subject to modification or revocation upon administrative or judicial review, including review and amendment pursuant to Water Code section 13330, and California Code of Regulations, title 23, chapter 28, Article 6 commencing with sections 3867-3869, inclusive. Additionally, the Los Angeles Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Permittee, if the Los Angeles Water Board determines that: the Project fails to comply with any of the conditions of this Order; or, when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.) or federal Clean Water Act section 303 (33 U.S.C. § 1313). For purposes of Clean Water Act section 401(d), the condition constitutes a limitation necessary to assure compliance with water quality standards and appropriate requirements of state law.
- 2. This Order is not intended and shall not be construed to apply to any activity involving a hydroelectric facility requiring a Federal Energy Regulatory Commission (FERC) license or an amendment to a FERC license, unless the pertinent certification application was filed pursuant to subsection 3855(b) of chapter 28, title 23 of the California Code of Regulations, and that application specifically identified that a FERC license or amendment to a FERC license for a hydroelectric facility was being sought.
- 3. This Order is conditioned upon total payment of any fee required under title 23 of the California Code of Regulations and owed by the Permittee.
- 4. In the event of any violation or threatened violation of the conditions of this Order, the violation or threatened violation shall be subject to any remedies, penalties, process, or sanctions as provided for under state and federal law. For purposes of Clean Water Act, section 401(d), the applicability of any state law authorizing remedies, penalties, processes, or sanctions for the violation or threatened violation constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements incorporated into this Order.

# E. General Compliance

- Failure to comply with any condition of this Order shall constitute a violation of the Porter-Cologne Water Quality Control Act and the Clean Water Act. The Permittee and/or discharger may then be subject to administrative and/or civil liability pursuant to Water Code section 13385.
- 2. Permitted actions must not cause a violation of any applicable water quality standards, including impairment of designated beneficial uses for receiving waters as adopted in the Basin Plans by any applicable Los Angeles Water Board or any applicable State Water Board (collectively Water Boards) water quality control plan or policy. The source of any such discharge must be eliminated as soon as practicable.
- 3. In response to a suspected violation of any condition of this Order, the Los Angeles Water Board may require the holder of this Order to furnish, under penalty of perjury, any technical or monitoring reports the Water Boards deem appropriate, provide that the burden, including costs, of the reports shall bear a reasonable relationship to the need for the reports and the benefits to be obtained from the reports. The additional monitoring requirements ensure that permitted discharges and activities comport with

any applicable effluent limitations, water quality standards, and/or other appropriate requirement of state law.

- 4. The Permittee must, at all times, fully comply with engineering plans, specifications, and technical reports submitted to support this Order; and all subsequent submittals required as part of this Order. The conditions within this Order and Attachments supersede conflicting provisions within Permittee submittals.
- 5. This Order and all of its conditions contained herein continue to have full force and effect regardless of the expiration or revocation of any federal license or permit issued for the Project. For purposes of Clean Water Act, section 401(d), this condition constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements of state law.
- 6. Construction General Permit Requirement: The Permittee shall maintain compliance with conditions described in, and required by, NPDES General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities (Order No. 2009-0009-DWQ; NPDES No. CAS000002, as ammended).

# F. Administrative

- 1. Signatory requirements for all document submittals required by this Order are presented in Attachment B of this Order.
- 2. This Order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act, which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish & G. Code, §§ 2050-2097) or the federal Endangered Species Act (16 U.S.C. §§ 1531-1544). If a "take" will result from any act authorized under this Order held by the Permittee, the Permittee must obtain authorization for the take prior to any construction or operation of the portion of the Project that may result in a take. The Permittee is responsible for meeting all requirements of the applicable endangered species act for the Project authorized under this Order.
- 3. The Permittee shall grant Los Angeles Water Board staff, or an authorized representative (including an authorized contractor acting as a Water Board representative), upon presentation of credentials and other documents as may be required by law, permission to:
  - **a.** Enter upon the Project or compensatory mitigation site(s) premises where a regulated facility or activity is located or conducted, or where records are kept.
  - **b.** Have access to and copy any records that are kept and are relevant to the Project or the requirements of this Order.
  - **c.** Inspect any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order.
  - d. Sample or monitor for the purposes of assuring Order compliance.
- **4.** A copy of this Order shall be provided to any consultants, contractors, and subcontractors working on the Project. Copies of this Order shall remain at the Project

site for the duration of this Order. The Permittee shall be responsible for work conducted by its consultants, contractors, and any subcontractors.

- **5.** A copy of this Order must be available at the Project site(s) during construction for review by site personnel and agencies. All personnel performing work on the Project shall be familiar with the content of this Order and its posted location at the Project site.
- 6. Lake and Streambed Alteration Agreement The Permittee shall submit a signed copy of the Department of Fish and Wildlife's lake and streambed alteration agreement to the Los Angeles Water Board immediately upon execution and prior to any discharge to waters of the state.
- This Certification shall expire five (5) years from date of this Certification. The Applicant shall submit a complete application at least 90 days prior to termination of this Certification if renewal is requested.

# G. On-site Mitigation for Temporary Impacts

 The Permittee shall restore all areas of temporary impacts to waters of the state and all Project site upland areas of temporary disturbance which could result in a discharge of waters of the state

#### H. Best Management Practices

#### 1. Measures to Protect Wildlife

- In compliance with the Migratory Bird Treaty Act and the California Fish and Game Code, the following measures shall be implemented during construction to avoid and minimize impacts on nesting birds:
  - Construction areas shall be reduced to the maximum extent feasible to avoid impacts on migratory birds and raptors.
  - Construction activities within 300 feet of potential nesting areas (500 feet for potential raptor nests) shall be scheduled outside of the nesting bird season (typically February 15 to September 15) to the extent feasible. Vegetation trimming for the project shall be minimized and shall be performed outside of the nesting season to the extent feasible.
  - If vegetation trimming or clearing is conducted during the nesting season, nesting bird surveys shall be completed by a qualified biologist no more than 48 hours prior to trimming or clearing activities to determine if nesting birds are within the affected vegetation. Surveys shall be repeated if trimming or removal activities are suspended for five days or more.
- If construction is scheduled during bird nesting season, nesting bird surveys shall be completed no more than 48 hours prior to construction to determine if nesting birds or active nests are on the bridge, beneath the bridge, or within 300 feet of the construction area. Surveys shall be repeated if construction activities are suspended for five days or more.
- If nesting birds are found in the project area, appropriate buffer areas (typically 300 feet for songbirds and up to 500 feet for raptors) shall be implemented, in coordination with

the appropriate resource agencies, to ensure that nesting birds and active nests are not harmed.

- To avoid and minimize potential impacts on bats, the following measures shall be implemented:
  - During the non-breeding season (typically October 1-April 31), the bridge structure shall be thoroughly surveyed for bats by a qualified biologist with bat experience, approved by CDFW, to identify any active or potential bat-roosting cavities. If any bats are found roosting in the bridge, they shall be safely excluded under the direction of the approved biologist and under consultation with the CDFW.
  - Once it has been determined that all roosting bats have been safely excluded from the bridge, exclusionary devices approved by the CDFW shall be installed and maintained to prevent bats from roosting in these areas prior to and during construction. A summary report shall be prepared upon completion of these activities and submitted to the CDFW.
- Vegetation removed from the biological study area (BSA) shall be treated and disposed of in a manner that shall prevent the spread of invasive species on- or off-site. New landscaping materials, including erosion control seed mixes, shall be composed of noninvasive species, and all erosion control and landscape planting shall be conducted in a manner that shall not result in the spread of invasive species.

# 2. Good Site Management "Housekeeping"

- Work areas shall be reduced to the extent feasible to avoid Ballona Creek and minimize impacts on jurisdictional areas.
- Staging areas shall be outside the channel to reduce direct and indirect impacts on Ballona Creek.
- BMPs shall be implemented during construction to minimize the potential for concrete dust, debris, paint chips, rust, and construction materials to fall into the channel, or otherwise leave the construction area.
  - Possible methods to prevent materials from falling into the channel include tenting or constructing a debris-catching platform below the bridge.
- All equipment refueling and maintenance shall be conducted in the staging area per standard specifications. In addition, BMPs shall be implemented during construction to reduce potential impacts associated with leaks and spills of oil, fuel, or machinery fluids.
- All trash and construction debris shall be removed from the channel and construction areas on a daily basis. All BMPs shall be properly maintained during project construction, and removed upon completion of construction activities. After completion of the project, all construction equipment, materials, and scaffolding shall be removed from the BSA, and the BSA shall be returned to pre-project conditions.

The project shall comply with the local regulations associated with the Los Angeles Water Board's Municipal Stormwater Permit issued to Los Angeles County and copermittees under NPDES No. CAS004001 and Waste Discharge Requirements Order No. R4-2012-0175.

I hereby issue the Order for the HIGUERA STREET BRIDGE PROJECT, 4WQC40114109 certifying that as long as all of the conditions listed in this Order are met, any discharge from the referenced Project will comply with the applicable provisions of Clean Water Act sections 301 (Effluent Limitations), 302 (Water Quality Related Effluent Limitations), 303 (Water Quality Standards and Implementation Plans), 306 (National Standards of Performance), and 307 (Toxic and Pretreatment Effluent Standards).





The Active Discharge Period includes all elements of the Project including site construction and restoration, and any Permittee responsible compensatory mitigation construction.
- 2. <u>Request for Notice of Completion of Discharges Letter:</u> This request by the Permittee to the Los Angeles Water Board staff pertains to projects that have post construction monitoring requirements, e.g. if site restoration was required to be monitored for 5 years following construction. Los Angeles Water Board staff will review the request and send a Completion of Discharges Letter to the Permittee upon approval. This letter will initiate the post-discharge monitoring period and a change in fees from the annual active discharge fee to the annual post-discharge monitoring fee.
- 3. <u>Request for Notice of Project Complete Letter:</u> This request by the Permittee to the Los Angeles Water Board staff pertains to projects that either have completed post-construction monitoring and achieved performance standards or have no post-construction monitoring requirements, and no further

Project activities are planned. Los Angeles Water Board staff will review the request and send a Project Complete Letter to the Permittee upon approval. Termination of annual invoicing of fees will correspond with the date of this letter.
