ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; CALIFORNIA DEPARTMENT OF WATER RESOURCES, LAKE OROVILLE MARINA LOW WATER ACCESS PROJECT (WDID NO. 5A04CR00292A1), BUTTE COUNTY

This Order responds to the 9 August 2023 request for an amendment to the California Department of Water Resources, Lake Oroville Marina Low Water Access Project (Project) Section 401 Water Quality Certification (WDID No. 5A04CR00292). The original Water Quality Certification was issued on 14 August 2018. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

California Department of Water Resources (hereinafter Permittee) is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the original expiration date of 14 August 2023 to align with the United States Army Corps of Engineers (USACE) Nationwide Permit 42 expiration date of 14 March 2026. The request has been approved and the expiration date of the Section 401 Water Quality Certification is **extended to 14 March 2026**. The extension is not valid until Section 404 authorization has been issued by the USACE for the Project. No additional work may be conducted that was not included and authorized in the original certification.
